The Supreme Court of Pakistan has passed an order against Private Educational Institutes on 'Illegal Fee Hike'

**Order Applies to All Private Schools Throughout Pakistan** 



### **Crux of Supreme Court Order**

The Supreme Court of Pakistan in its hearing dated 10<sup>th</sup> January 2019 has categorically ordered to all schools which charging fees in excess of Rs. 5,000/- per month throughout Pakistan without exception for the

#### Reduction in Tuition Fee by 20 percent

Note: That the reduction of 20% shall be made on amounts in excess of Rs. 5000/- which essentially means that notwithstanding the total amount of fee, the first Rs. 5000/- is exempt from reduction of 20% and such reduction would only be applicable to amounts in excess of Rs 5000- per month

- Refund/Adjustment of 50 percent Summer Vacation Fee
- Increase in the Annual Fees upto 5 percent

Note: Required Regulatory Approval for any increase between range of 6-8 percent)

It was also directed that no school shall under any circumstances be closed nor the students be expelled from such schools.



### What Parents should do now?



ASPA has drafted a <u>letter</u> for ALL parents which is to be submitted at the school along with the copies of paid / unpaid vouchers that you have lastly received.



This <u>letter</u> can be used by all parents whose kids are studying in private educational institutes operating under the ""The Sindh Private Educational Institutions (Regulation & Control) Rules, 2005"

- d) Must obtain receiving on Photo Copy of your original letter
- e) Send a Soft Copy of the Letter via email to the school's official email address
